Harrison Products conducts its business in accordance with its Ethical Trading Policy and expects its Suppliers to observe this and to demonstrate a similar commitment to its ongoing ethical and environmental practices.



Health and Safety

We aim to achieve and maintain the highest standards of health and safety to provide a safe and healthy working environment. We have a current and effective written Health & Safety Policy that is regularly reviewed and updated, as required.

Environment

We are aware of our environmental impact as a business and have taken and continue to take appropriate steps to mitigate that impact, including setting environmental objectives and targets, implementing procedures, and providing training so employees understand their responsibilities and can seek to improve our environmental performance.

As part of our commitment to continually improve our business practices, we have been working with <u>CarbonQuota</u> to measure, reduce, and certify the carbon footprint of our direct operations. As of February 2023 we are a certified carbon reduced operation, and have reduced our Carbon Footprint by 26 tonnes of CO2e in the last year.

We have worked with both <u>EcoVadis</u> to improve our sustainability practices and effectively manage corporate social responsibility, achieving the Gold Rating, and <u>Sedex</u> to become a responsible business, improving ethical standards and working conditions within the supply chain.

We are accredited by the International Organisation of Standardisation as conforming to ISO 14001:2015 in having an effective environmental management system and continually update our processes to minimise our impact.

As of 2022, our Harrison parcel packaging is 100% plastic free, made from 80% recycled and 100% recyclable cardboard, and contains cardboard infill made by our in-house shredder. Our Green Promise also includes our pledge to increase our range of Ecovision 100% recyclable, biodegradable, and sustainable products. Our philanthropy includes the plantation of 100 trees every month with <u>One Tree Planted</u> and supporting the ongoing work of <u>The Ocean Cleanup</u>.

The Community

We recognise and understand the significance of the local community within which we operate. We aim to enhance our contribution by being sensitive to the needs of local people and promoting ethical, socially-responsible trading.
